



Recreation Vehicle (RV) and Trailer Owners

Recreation Vehicles, including travel trailers, converted buses/vans, airstreams, etc., have the potential to discharge pollutants that can harm our creeks and waterways if they enter the storm drain system. When trash and sewage are dumped into the street and storm drain inlets, they flow through the storm drain system to our local waterways, the Bay, and eventually the ocean without any cleaning or filtering. Federal, state, and local regulations prohibit discharge of anything but rainwater in the storm drain.

Help protect the San Francisco Bay and local creeks by following these Best Management Practices (BMPs).




Never allow discharges to enter storm drains. Federal, state, and local regulations prohibit anything other than rain into the storm drain.

SERVICE WASTEWATER TANKS REGULARLY

- NEVER** dump wastewater, sewage, or greywater into the street, gutter, or storm drain.
- Dispose of wastewater or sewage at an appropriate disposal location or hire a waste hauler to empty your tanks. *See the reverse side for locations in Santa Clara Valley.*
- Do not over fill tanks. Secure wastewater tank cap to prevent leaks.
- Service tanks regularly to avoid leaks.

KEEP TRASH AND MATERIALS CONTAINED

- NEVER** dump trash in the storm drain or street.
- Dispose of trash in a trash bag or covered trash can.
- Pick up trash or debris around your RV.
- Do not store materials outside of your RV.



PREVENT/FIX VEHICLE AND EQUIPMENT LEAKS

- Do not park if there are storm drains located nearby.
- Periodically check under the engine for leaks.
- Use drip pans for any leaks from the waste tank, engine, refrigeration equipment, etc., and repair immediately.
- Ensure that all caps are properly installed, closed, and fit tightly.
- Have the propane system leak-tested annually.

The following may result in a fine and assessment of any associated cleanup costs:

- Dumping wastewater into the street, gutter, or storm drain
- Dumping trash in any area not designated for trash disposal
- Vehicle or equipment leaks and spills

Parking limitations apply in certain cities. Check local jurisdiction for parking limits.
